

Unit (# of beds)	Floor	Description
Behavioral Health (121 beds)	Attached 3-floor facility	Inpatient mental health care divided into psychiatric intensive care (PICU), children, adolescent, integrated addiction recovery, general adult, affective disorders, seriously mentally ill, and geriatric units. (One group of students placed in the full facility.)
Emergency (41 beds)	1st	Treats patients of all age ranges with severe or sudden illness or injuries. Trauma patients are stabilized and transferred to a trauma facility.
Intensive Care Unit (24 MICU & 10 SICU)	2nd (MICU) and 3rd (SICU)	Patients include cardiac arrest, respiratory failure, ventilator support, multi-system failure, electrolyte imbalance, sepsis, renal failure, and arrhythmias. Surgical ICU patients include complex surgery and neurosurgery recovery.
Maternity (60 beds)	4th and 5th	Supports women through antepartum, labor, delivery, recovery, and postpartum care. Women stay in the same room for all phases of delivery and postpartum care. Obstetrical operating suite is attached to the unit for c-sections, tubal ligation, and other obstetrical related procedures.
Medical A (16 beds)	1st	Patient diagnoses include care for chronic and acute issues related to the lungs, endocrine, gastrointestinal, and genitourinary conditions. This unit incorporates transitional care nurses who assist patients with chronic diseases to achieve life goals and greater quality of life.
Medical B (14 beds)	3rd	Patient diagnoses include care for chronic and acute issues related to the lungs, endocrine, gastrointestinal, and genitourinary conditions. This unit incorporates transitional care nurses who assist patients with chronic diseases to achieve life goals and greater quality of life.
Medical C (30 beds)	3rd	Patient diagnoses include care for chronic and acute issues related to the lungs, endocrine, gastrointestinal, and genitourinary conditions. This unit incorporates transitional care nurses who assist patients with chronic diseases to achieve life goals and greater quality of life. This unit also provides care for stroke patients.
NICU (48 beds)	6th	Provides care for high-risk neonates from birth at 23 weeks gestation through 28 days postpartum. The unit includes 4 rooms for twins and 1 room for triplets. The most common reason for admission to this unit is respiratory distress and prematurity.
Oncology	3rd	Patient diagnoses include solid tumor cancers, lymphomas, hematological disorders, leukemia. Patient treatments include surgery, chemotherapy, and radiation therapy. A protective environment is established for patients requiring neutropenic precautions.
Ortho/Neuro/Spine (30 beds)	1st	Orthopedic, neurology, and spine patients plus a 12-bed Center for Joint Health which includes total joint replacements for knees and hips. Neurology patient types include stroke, seizures, and 24-hour outpatient video EEG.
Perioperative (10 ORs)	2nd	Performs both outpatient and inpatient procedures, averaging between 25 and 30 cases per day, including bariatric, laparoscopic, colon resection, spinal fusion, craniotomies, total joint replacement, nephrectomies, and many others.
Progressive Care Unit (32 beds)	2nd	Complex patient population which includes heart failure, renal failure, gastrointestinal complications, drug overdose stabilization, and neurology patients. May also have some progressive surgical patient recovery.
Surgical Unit (G2) (48 beds)	2nd	Unit with post-operative surgical patients, including gynecological, urological, colorectal, and other general surgery.
